# 6 Update from District Councillor, Keith Turner

## Housing

There has been no progress on the provision of affordable housing in Brompton Ralph as there is currently insufficient need identified. He asked the Council to encourage local people (in particular young adults) to register with Somerset Homefinder http://www.homefindersomerset.co.uk/ if they want to live independently, but cannot find or afford local housing.

We are encouraged to attend the next meeting on 6 October. We can send three representatives from the Parish Council, one of whom should be the Clerk as minute taking is to be shared between the parishes. Issues such as mobile phone coverage (the proposed mast at Raddington) and the Lengthsman scheme could usefully be addressed

### **Transfer of Assets**
